1. Definitions

6. Termination

1. Definitions

- a) "Invoice" means the computer-generated or pre-printed invoice issued by SP.com, which may include any limitations on the licence in addition to those specified herein and the corresponding price for the licence of the Licensed Images. The Invoice shall form an integral part of this Agreement.
- b) "Licensed Images" means any still image generated optically, electronically, digitally or by any other means, including any negatives, transparencies, film imprints, prints, original digital files or any Reproductions thereof,

6. Late payment

In any dispute between SP.com and you, SP.com shall be

entitled to recover its reasonable lawyer's fees, legal expert fees, and other legal expenses from you.

11. No Waiver / Severability

11.1 No action of SP.com, other than an express written Waiver or Amendment, may be construed as a waiver or amendment of this Website TCU's and/or Licensing Terms. Should any clause of these TCU's and/or Licensing Terms be found unenforceable, wherever possible this will not affect any other clause and each will remain in full force and effect.

12. Miscellaneous

12.1 You acknowledge that you have read these TCU's and Licensing Terms (Royalty Free and/or Managed Rights license agreements) and understand it, and agree to be bound by all their terms and conditions as well any additional terms set forth on your invoice. This document constitutes the entire agreement between the parties with respect to the subject matter hereof and replaces any and all prior and contemporaneous communications. This Agreement shall not be modified except by a written agreement signed by both you and SP.com. No purchase order or similar document issued by you shall modify these TCU's and/or Licensing Terms.
